WHEREAS, The City of San Diego is the owner of a certain easement for sewer purposes affecting a portion of Lot:,
Block 152 of University Heights, as acquired by deed
recorded December 7, 1926 in Book 1259, Page 459 of Deeds,

WHEREAS, said sewer easement was acquired to provide for private sewer laterals connecting two street side ownerships which have since merged into one parcel eliminating the need for the easement; and

- 3. That the City Clerk of said City is hereby authorized and directed to deliver said deed to the Property Director for further handling.
