- 2. That the Mayor and the City Clerk of The City of San Diego be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a grant deed, the form of which is on file in the office of the City Clerk as Document No.

, conveying to the STATE OF CALIFORNIA, a corporation sovereign, all of said City's interest in a portion of Oaks Tract of Rancho San Bernardo, as more particularly described in said form of grant deed.
