APPROVING MAP OF PACIFIC COAST BANK PLAZA SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:


Said Council hereby finds that that certain map surveyed by VICTOR T. WIGLESWORTH, Registered Civil Engineer, and entitled, "PACIFIC COAST BANK PLAZA Being a subdivision of a portion of the Northeast Quarter of Lot 62 of Horton's Purchase, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 283, filed in the office of the County Recorder of San Diego County, March 9, 1878; together with a portion of Logan Avenue as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portions of public streets, to wit: a portion of 49th Street and a portion of Logan Avenue for public purposes and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
