

RESOLUTION NO. 204151 NOV 4 1971

WHEREAS, The City of San Diego is the owner of a portion of Pueblo Lot 1305 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of the San Diego County Recorder on November 14, 1921, and is known as Miscellaneous Map No. 36; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for power line purposes over and across said property as the construction of Interstate 805 Freeway necessitated a temporary re-routing of electrical facilities in the Rose Canyon area; and

WHEREAS, it has been determined by a staff appraiser that the value of the property right sought is the sum of Nine Hundred Twenty-Five Dollars (\$925.00); and

WHEREAS, a fee of \$35.00 has been collected to cover the processing of this request;

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said

easement be conveyed to the San Diego Gas & Electric Company,
a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San
Diego, as follows:

That, in consideration of the benefits to accrue to the
people of said City, and the sum of \$960.00, the Mayor and
the City Clerk of said City be, and they are hereby authorized
and empowered to execute, for and on behalf of The City of
San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC
COMPANY, a corporation, an easement for power line purposes
over and across a portion of Pueblo Lot 1305 of the Pueblo
Lands of San Diego, as more particularly described in the
form of Deed of Easement, on file in the office of the City
Clerk as Document No. 737893.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
authorized and directed to deliver said deed to the Property
Director of said City for further handling.
