WHEREAS, on November 24, 1970 by Resolution No. 201308 the City Council authorized the Director of the Department of Legislative Representation to travel to San Juan, Puerto Rico for a meeting of the National Conference of State Legislative Leaders for the purpose of inviting that conference to stage its 1971 annual meeting in San Diego; and

WHEREAS, the National Conference of State Legislative Leaders has accepted that invitation and has scheduled its annual meeting to be held November 16 through November 19, 1971 in San Diego; and

WHEREAS, approximately 700 state legislators, primarily the elected heads of each of the nation's 50 state legislatures, as well as members of the United States House of Representatives, will attend this bi-partisan four day meeting; and

WHEREAS, certain expenses relating to transportation, equipment and decorations will be incurred; and

WHEREAS, the City Council desires to participate with the County of San Diego in sponsoring a welcoming reception on Tuesday evening, November 16, 1971; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council extends its welcome to the National Conference of State Legislative Leaders.
