

WHEREAS, it appears to be in the public interest to name the unnamed portion of the right-of-way between the southerly prolongation of the westerly boundary of Seven Inns Subdivision and the easterly right-of-way of State Highway 163, to CAMINO DE LA REINA, and to change the name of those portions of the right-of-way named Hotel Circle between the southerly prolongation of the westerly boundary of Seven Inns Subdivision and the easterly right-of-way of State Highway 163, to CAMINO DE LA REINA; and

WHEREAS, the Planning Commission of The City of San Diego has recommended approval of the naming of said unnamed portion and changing the name of said portions of Hotel Circle; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the unnamed portion of the right-of-way between the southerly prolongation of the westerly boundary of Seven Inns Subdivision and the easterly right-of-way of State Highway 163 be, and the same is hereby named CAMINO DE LA REINA.

2. That those portions of the right-of-way between the southerly prolongation of the westerly boundary of Seven Inns Subdivision and the easterly right-of-way of State Highway 163 named Hotel Circle be, and the same are hereby renamed CAMINO DE LA REINA.

3. That the City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
