

RESOLUTION NO. 204175

APPROVING MAP OF KEARNY MESA COMPLEX SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., Registered Civil Engineer, and entitled, "KEARNY MESA COMPLEX Being a subdivision of portions of Lots 7, 8, 9 and 10 of the Highlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 284, filed in the office of the County Recorder of San Diego County, March 6, 1887; together with that portion of the unnamed street, as vacated and closed to public use, adjoining Lot 7 on the East; together with that portion of Kearny Villa Way, formerly Main Street, as vacated and closed to public use, adjoining Lot 10 on the West.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of public streets, to wit: Complex Drive, Complex Street, a portion of Kearny Villa Road and a portion of Kearny Villa Way, for public purposes, and said streets and portions of public streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the

easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
