

RESOLUTION NO. 204176 NOV 9 1971

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public sewer and appurtenances thereto, through, over,
under, along and across the hereinafter described property,
be, and the same is hereby set aside for such public
purposes:

All that portion of Pueblo Lots 1277 and 1278 of
the Pueblo Lands of San Diego in the City of San
Diego, County of San Diego, State of California
according to map thereof made by James Pascoe in
1870, a copy of which map was filed in the Office
of the County Recorder of said County on November 14,
1921 as Miscellaneous Map No. 36, being a strip of
land 15.00 feet in width lying 10.00 feet Southerly
and 5.00 feet Northerly of the following described
line:


Commencing at the most Easterly corner of Lot 813
of University Hills Unit No. 11 according to Map
thereof No. 6329 filed in the Office of said County
Recorder; thence along the Northerly boundary line
of said University Hills Unit No. 11 North 43°00'32"
West, 244.39 feet; thence leaving said boundary line
North 12°00'00" East, 148.00 feet to the TRUE POINT
OF BEGINNING; thence North 77°44'00" West, 85.00 feet;
thence North 43°06'00" West, 150.00 feet; thence
North 64°44'55" West, 226.73 feet; thence North
80°00'00" West, 350.00 feet; thence North 73°16'50"
West, 350.00 feet; thence North 83°22'13" West,
350.00 feet; thence South 65°00'00" West, 350 feet;
thence North 87°00'34" West, 143.44 feet to a point
of terminus.

The sidelines of the above described strip of land
shall be prolonged or shortened so as to terminate
in a line that bears North 12°00'00" East, through
the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
