

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public street and incidents thereto, through, over, under,
along and across the hereinafter described property be, and
the same is hereby set aside and dedicated as and for a public
street and the same is hereby named ROCKWOOD ROAD:

That portion of Section 20, Township 12 South,
Range 1 West, San Bernardino Base and Meridian,
in the City of San Diego, County of San Diego,
State of California, according to official plat
thereof, lying within a strip of land 84.00 feet
wide, the centerline of said strip being described
as follows:

Beginning at the intersection of the Easterly
line of Rancho Rincon del Diablo according to
Map thereof No. 725, on file in the Office of
the Recorder of said County with a line and its
Easterly prolongation that is parallel with and
33.00 feet Northerly of the Northerly line of
Lot 5 in Block 266 of said Rancho Rincon del
Diablo; thence Easterly along said prolongation
to the beginning of a 700.00 foot radius curve
concave Northerly that is tangent both to said
parallel line and to a line that is parallel with
and 42.00 feet Southerly of a boundary line of
that parcel of land deeded to the City of San
Diego by deed recorded in Book 4982, Page 371,
Official Records, said boundary line being
described in said deed as bearing North 89°18'20"
East, a distance of 660.00 feet; thence along
said 700.00 foot radius curve to the point of
tangency with last mentioned parallel line; thence
Easterly along said parallel line to a point on
the boundary of said City of San Diego land.

The sidelines of said 84.00 foot strip are to be
prolonged or shortened as necessary to terminate
on the West on the boundary line of said Rancho
and on the East on the boundary of said City of
San Diego land.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
