

RESOLUTION NO. 204180 NOV 9 1971

WHEREAS, The City of San Diego is the owner of a certain easement for sewer purposes affecting portions of Lots 32 and 33, Pauly's Addition, according to Map thereof No. 265, filed April 1, 1873, in the office of the San Diego County Recorder, together with a portion of Mississippi Street as closed November 22, 1910 by Ordinance No. 4285 of the Council of The City of San Diego; and

WHEREAS, the owners of said Lots 32 and 33 have requested an exchange of easements to allow better development of the land; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; and

WHEREAS, the value of the property rights to be exchanged are equal, as determined by the Property Department staff of said City, being the sum of \$100.00 each; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 737934, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD of Lots 32 and 33, Pauly's Addition, an existing easement for sewer purposes affecting portions of Lots 32 and 33, Pauly's Addition, according to Map thereof No. 265, filed April 1, 1873, in the office of the San Diego County Recorder, together with a portion of Mississippi Street as closed November 22, 1910 by Ordinance No. 4285 of the Council of The City of San Diego, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Mayor of said City for execution and transmittal to the Property Director of said City for recordation.
