BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of City, an agreement with DALE BUILDING COMPANY, a California corporation, for the construction of a 30-inch drain and to improve Coronado Avenue, in CORONADO TERRACE UNIT NO. 1 subdivision, and to provide for reimbursement by the City in an amount not to exceed \$4,062.00 out of Capital Outlay Fund 245 for the 30-inch drain and in an amount not to exceed \$2,952.00, out of Gas Tax Fund 219 for the improvements of Coronado Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 737935
