

RESOLUTION NO. 201229

WHEREAS, Resolution No. 203374, adopted August 5, 1971, authorized the Mayor and City Clerk to execute, for and on behalf of the City, a Deed of Easement conveying to San Diego Gas & Electric Company, a corporation, a portion of Oaks Tract in Rancho San Bernardo, all as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. 736874; and

WHEREAS, said easement has proven to be unusable for underground electrical conduit purposes inasmuch as it overlaps an existing nonexclusive water pipeline easement; and

WHEREAS, said Resolution No. 203374 should be rescinded and said deed cancelled; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 203374, adopted by the Council of The City of San Diego on August 5, 1971, be, and the same is hereby rescinded, and that deed authorized to be executed thereby, a copy of which is on file in the office of the City Clerk as Document No. 736874, be, and it is hereby cancelled.
