That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BRINK & ROBERTS, ARCHITECTS, for professional services required to rehabilitate and reconstruct the Villa Montezuma Historical Site, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 738050.

BE IT FURTHER RESOLVED, that the expenditure of \$52,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the professional services and reconstruction costs described above and related expenses.
