Courtesy Chevrolet are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of AUTOMOTIVE EQUIPMENT for Police, Fire and Model Cities Department as follows:
- A. Center City Motors dba Center City Ford for:
 - (1) Section I, Item 1, ninety-four Sedans at a cost of \$2,943.00 each; and Item 2, six Sedans at a cost of \$2,966.00 each for a total cost of \$294,438.00; terms net 30 days, plus sales tax, less trade-in and buy-back allowance for an estimated ninety-four sedans of \$54,845.00.
 - (2) Section III: Two Ambulance Vans for a total cost of \$7,167.00; terms net 30 days, plus sales tax.
 - B. Bay Ford for Section II: One Four-Door Hardtop Sedan at a cost of \$4,208.00; terms net 30 days, plus sales tax.
 - C. Carl Burger Dodge for Section IV: Nine Passenger Vans for a total cost of \$34,809.57; terms net 30 days, plus sales tax.
