That the law firm of GRAY, CARY, AMES & FRYE be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the improvements to be made in the COTTONTAIL LANE UNDERGROUND UTILITY DISTRICT under the provisions of the Municipal Improvement Acts of 1911 and 1913, pursuant to the terms and conditions set forth in the letter dated November 8, 1971, on file in the office of the City Clerk as Document No.

That in the event the proposed Improvement Acts proceedings fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
