RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO DECLARING THE RESULTS OF THE  
SPECIAL MUNICIPAL BOND ELECTION HELD IN  
SAN DIEGO ON NOVEMBER 2, 1971.

WHEREAS, this Council by Ordinance No. 10674 (New Series) adopted August 31, 1971, called a Special Municipal Bond Election to be held in the City on November 2, 1971; and

WHEREAS, this Special Municipal Bond Election was duly consolidated with the General Municipal Election held upon the same date; and

WHEREAS, the Special Municipal Bond Election was held on November 2, 1971, for the purpose of proposing and submitting to the qualified electors of the City the following proposition to incur indebtedness and issue bonds in the principal amount indicated therein as follows:

PROPOSITION A

PROPOSITION A. CITY OF SAN DIEGO BALBOA PARK MUSEUM, GALLERY AND EXHIBITION FACILITIES BOND PROPOSAL: To improve, develop and expand the historical, museum, art gallery, exhibition, cultural, educational and recreational services of the City, shall the City incur a bonded indebtedness in the principal amount of two million eight hundred fifty thousand dollars to permit the acquisition, improvement, construction or completion of the Ford Building and an east wing to the Fine Arts Gallery in Balboa Park, the latter only if matching funds are available from private or other public sources? WHEREAS, a copy of the certificate of the Registrar of Voters of the County of San Diego canvassing the returns of the Special Municipal Bond Election, including absentee votes cast, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of the Special Municipal Bond Election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

1. The whole number of votes including absentee votes cast in the City of San Diego Special Municipal Bond Election is 178,129.

2. The number of votes including absentee votes cast for and against the bond proposition which appeared on the ballot as proposition lettered A, and the total number of votes cast upon the bond proposition, including absentee votes, is as follows:



3. The proposition was not approved by the vote of a two-thirds majority of the qualified voters voting on the proposition and is hereby declared to have failed.

4. The number of votes cast for and against the proposition, including absentee votes, is recorded in the Election Returns Book of The City of San Diego, which book is a part of the records of this Council.

5. The City Clerk shall make public the results of the canvass of the Special Municipal Bond Election by a publication of a copy of this resolution.
