APPROVING MAP OF VIA MIRAMAR SUBDIVISION.


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by GARY L. MC CABE, Registered Civil Engineer, and entitled, "VIA MIRAMAR Being a subdivision of a portion of the Southwest Quarter of the Southeast Quarter of Section 6, Township 15 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 19, 1883.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public street and portion of public street, to wit: Black Mountain Road and a portion of Miramar Road for public purposes, and said street and portion of street are hereby declared to be public street and portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
