

RESOLUTION NO. 204329 DEC 7 1971

APPROVING MAP OF FRIARS VILLAGE UNIT NO. 3 SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "FRIARS VILLAGE UNIT NO. 3 Being a subdivision of a portion of Lot 2 of Monterey Club, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6591, filed in the office of the County Recorder of San Diego County, February 20, 1970.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Camino Copete, for public purposes and said street is hereby declared to be public street and dedicated to the public use.

The said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Linda Vista Road, adjacent and contiguous to Lots 312-A and 313-A, all as granted and shown on said map.

The said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of

water facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The said Council accepts on behalf of The City of San Diego, a municipal corporation, the easement for access purposes, together with the easement for general utility and open space as listed in the owners certificate on the map, subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with that certain easement with the right of ingress and egress for the construction and maintenance of water facilities and the easements for access purposes, general utility and open space, as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
