That the expenditure of \$914,600 and \$31,400 is hereby authorized out of Gas Tax Fund 220 and Sewer Revenue Fund 506, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's contribution toward the cost of the improvement of GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD and MOUNT ALIFAN DRIVE, in the City of San Diego, pursuant to Resolution of Intention No. 203414 under the 1911 Act proceedings.
