RESOLUTION NO. 204341

WHEREAS, The City of San Diego heretofore entered into an agreement with ALICE M. DUTTON, "Subdivider," 7912 Calle de la Plata, La Jolla, California, to construct certain improvements in ALICE TERRACE subdivision, which agreement is filed in the office of the City Clerk as Document No. 701836; and

WHEREAS, in connection with the performance of said agreement, \$505.00 in cash, City Engineer's Receipt No. 5125, was deposited with the City Engineer on June 20, 1966; and

WHEREAS, Subdivider has not complied with the terms and provisions of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That ALICE M. DUTTON is hereby DECLARED TO BE IN DEFAULT of the terms and conditions of the agreement on file in the office of the City Clerk as Document No. 701836 on July 21, 1966, relating to the improvement of ALICE TERRACE subdivision.

2. That the City Attorney shall cause notice of this declaration of default to be given to said ALICE M. DUTTON.

3. That the City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of said agreement.

4. That the City Clerk is hereby directed to forward a certified copy of this resolution to the County Recorder.
