BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, PARKING OF VEHICLES IS HEREBY PROHIBITED between the hours of 8:00 a.m. to 10:00 a.m. on the west side of the following street in said City:

COAST BOULEVARD between South Coast Boulevard, northerly intersection near Cuvier Street and South Coast Boulevard, southerly intersection near La Jolla Boulevard.

BE IT FURTHER RESOLVED, that the necessary signs and markings be, and the same are hereby authorized and directed to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
