2. That the expenditure of \$270,000.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF SEWER MAIN REPLACEMENTS - GROUP 13 (ARIZONA STREET BASIN - PHASE II) in the City of San Diego, and related costs.
