


RESOLUTION No. 204411

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$85,804.00 by Larry Montoya dba Larry Montoya Gen. Bldg. Contr., for the CONSTRUCTION OF BORDER JUVENILE CHECK STATION (Base Bid and Additive Alternates Nos. 2, 3, 4 and 6) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 737453.
2. That the expenditure of \$99,040.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF BORDER JUVENILE CHECK STATION (Base Bid and Additive Alternates Nos. 2, 3, 4 and 6) in the City of San Diego, and related costs and supplementing Resolution No. 202301 for this purpose and related work.
