That the acceptance by the City Manager of that deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date October 6, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of the Southwest Quarter of the Southwest Quarter of Section 31, Township 14 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GOLD COAST DRIVE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
