George P. Mitchell	POLICE DEPARTMENT	\$95	Two departmental publications, "The Monthly Report" and the "Traffic Report," were issued on a monthly basis. It was suggested and found that these could be made quarterly reports without any loss of effectiveness. This saves 8 issues of each and about \$950 a year.
Mary M. Barta	WATER UTILITIES DEPARTMENT	\$90	New Services Notices were formerly typed letters to the customers. It was suggested that the computer be programed to produce a notice at the same time it is posting the transaction code. This makes a net saving of about \$886 per year and also speeds up the process.
