RESOLUTION AMENDING RESOLUTION OF INTENTION NO. 204071 BY APPROVING PLANS AND PROFILES SHOWING CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED THEREIN FOR THE IMPROVEMENT OF SPRUCE STREET, ALLEY IN BLOCK 10, LA MESA COLONY, AND ALLEY IN BLOCK 17, SUBDIVISION OF LOTS 20 TO 50, BLOCK N, TERALTA.

WHEREAS, this City Council did on October 26, 1971, adopt Resolution of Intention No. 204071 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the plans, profiles and drawings adopted by said Resolution of Intention, to realign curb on SPRUCE STREET so that an existing tree need not be removed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Drawing No. 14695-1-D heretofore filed in the office of the City Clerk under Document No. 737721 for the improvement of SPRUCE STREET, et al., and the plans, drawings,

typical cross-sections, profiles and specifications be, and the same are hereby amended to conform with Drawing No. 14695-1-D on file in the office of the City Clerk as Document No. 738401, and the same is hereby approved and adopted, along with Drawing Nos. 14695-2-D, 14695-3-D and 14695-4-D as previously approved by Resolution No. 204070 and on file in the office of the City Clerk as Document No. 737721, as the official drawings, typical cross-sections, profiles and specifications for said work and improvements.
