DEL MAR HEIGHTS,

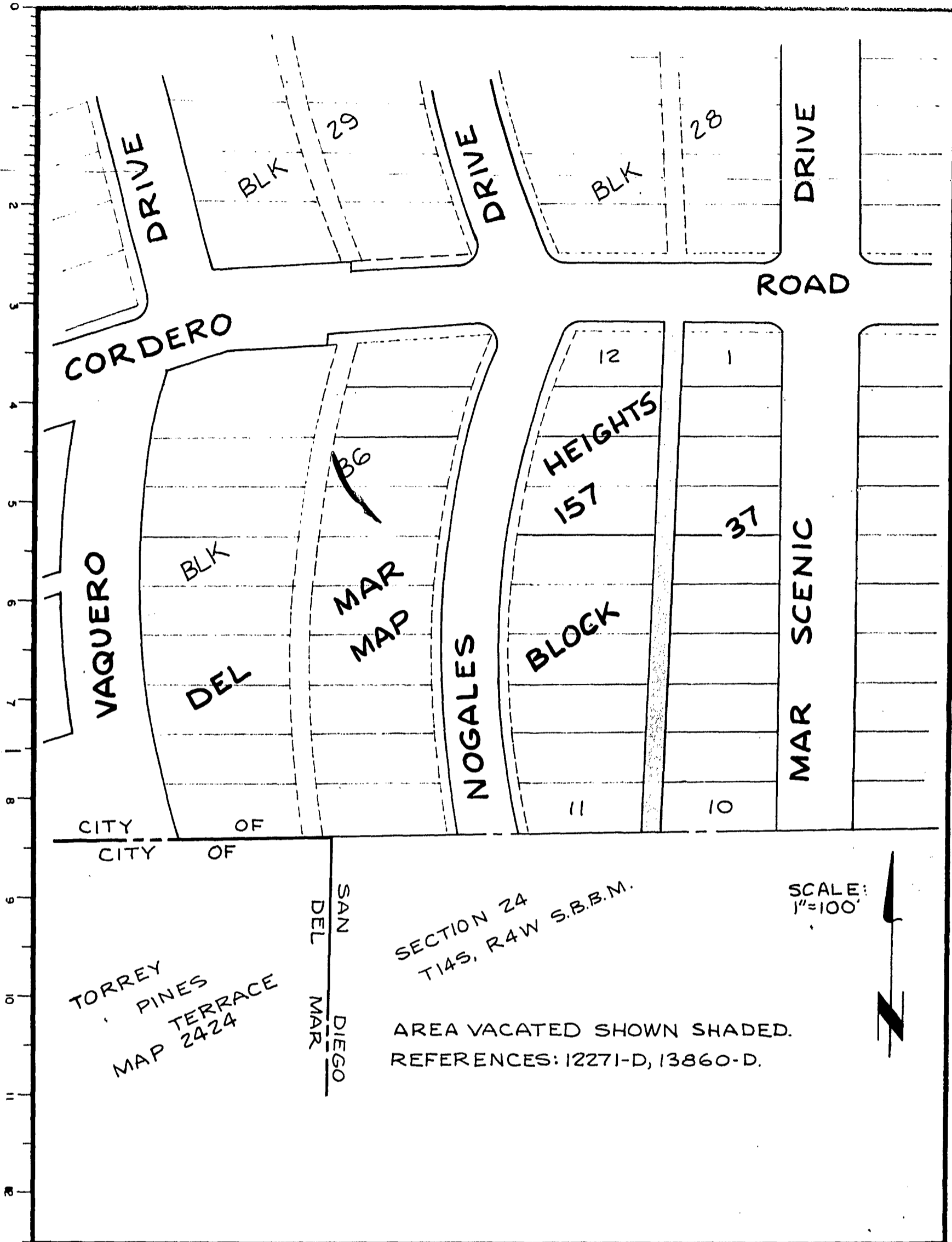
as more particularly shown on Map No. 12703-B, on file in the
