BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$129,009.78 by Meri-Rich Corp., A Corporation, for the IMPROVEMENT OF MARTIN AVENUE BETWEEN 32ND STREET AND GREGORY STREET; "J" STREET BETWEEN 33RD STREET AND 34TH STREET; WEBSTER AVENUE BETWEEN 33RD STREET AND WABASH BOULEVARD; GREELY AVENUE BETWEEN PAYNE STREET AND 33RD STREET; PAYNE STREET SOUTHERLY OF GREELY AVENUE; BANCROFT STREET BETWEEN OCEANVIEW BOULEVARD AND MARTIN AVENUE (Base Bid including Alternate "A") in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738021.

That the expenditure of \$137,570.00 is hereby authorized out of HUD'S Federal Grant for Model Cities Streets and Alleys Fund (2532) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF MARTIN AVENUE BETWEEN 32ND STREET AND GREGORY STREET; "J" STREET BETWEEN 33RD STREET AND 34TH STREET; WEBSTER AVENUE BETWEEN 33RD STREET AND WABASH BOULEVARD; GREELY AVENUE BETWEEN PAYNE STREET AND 33RD STREET; PAYNE STREET SOUTHERLY OF GREELY AVENUE; BANCROFT STREET BETWEEN OCEANVIEW BOULEVARD AND MARTIN AVENUE (Base Bid including Alternate "A") in the City of San Diego, and related costs.
