RESOLUTION NO. 204478

APPROVING MAP OF VILLA SAN ANTONIO SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "VILLA SAN ANTONIO Being a subdivision of Lots 2 and 7 in Block 19 of the Beach Lots, said Block 19 being generally known as and called Block 123 of La Playa, in the City of San Diego, County of San Diego, State of California, according to the map of said Beach Lots made by Cave J. Coutts in 1849, a copy of which said map was filed in the office of the Recorder of said San Diego County December 12, 1921 and is known as Miscellaneous Map No. 37, together with all that portion of the easterly 25 feet of San Antonio Avenue, lying westerly of and adjoining said Lot 2, as vacated and closed to public use on May 25, 1914 by Resolution No. 17359 of the Common Council of the City of San Diego.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of San
Diego, California.
