BE IT RESOLVED, by the Council of The City of San Diego,
California, that THE EAST-WEST ALLEY, BLOCK 21, L. W.
KIMBALL'S SUBDIVISION AND BERENSONIA TRACT,

as more particularly referred to in Resolution of Intention

No. 204330 is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the public interest, convenience and necessity of said City requires the reservation of certain public easement(s), as more particularly referred to in Resolution of Intention No. 204.330.

BE IT FURTHER RESOLVED, that THE EAST-WEST ALLEY,
BLOCK 21, L. W. KIMBALL'S SUBDIVISION AND BERENSONIA TRACT,

as more particularly shown on Map No. 12,569-B on file in the office of the City Clerk as Document No. 738227, which said map is attached hereto marked Exhibit and made a part hereof, be, and the same is hereby vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easement(s) as more particularly shown on Map No. 12,569-B , on file in the office of the City Clerk as Document No. 738227 , and as more particularly described hereinafter:

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating sewer facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City, the owners of the underlying fee may utilize the above-described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easement reserved herein is in, under, over, upon, along and across the following described property:

All that portion of the ALLEY in BLOCK 21, L. W. KIMBALL'S SUBDIVISION as vacated, as established according to the map of L. W. Kimball's Subdivision, on file in the office of the County Clerk of San Diego County, lying 7.50 feet on each side of the following described centerline:

Beginning at the southwest corner of Lot 10, Block 21 of said L. W. Kimball's Subdivision; thence southerly along the southerly prolongation of the westerly line of said Lot 10, a distance of 10.00 feet to a point; thence in a straight line to a point on the north line of Lot 38, Block 21, said point being 0.53 feet westerly of the northeast corner of said Lot 38, said point also being the point of termination of the herein described centerline.

The sidelines of the above described easement shall be lengthened and/or shortened so as to terminate in the boundaries of the above described land.

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating drainage facilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easement reserved herein is in, under, over, upon, along and across the following described property:

All that portion of the ALLEY in BLOCK 21, L. W. KIMBALL'S SUBDIVISION as vacated, as established according to the map of L. W. Kimball's Subdivision, on file in the office of the County Clerk of San Diego County, lying 5.00 feet on each side of the following described centerline:

Beginning at the southwest corner of Lot 11, Block 21, of said L. W. Kimball's Subdivision; thence easterly along the southerly line of said Lot 11 a distance of 1.91 feet to the TRUE POINT OF BEGINNING of the herein described centerline; thence in a straight line to a point on the north line of Lot 37, Block 21, said point being 2.86 feet westerly of the northeast corner of said Lot 37, said point also being the point of termination of the herein described centerline.

The sidelines of the above described easement shall be lengthened and/or shortened so as to terminate in the boundaries of the above described land.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, including the attached map, attested by him under seal, to be recorded in the office of the County Recorder.

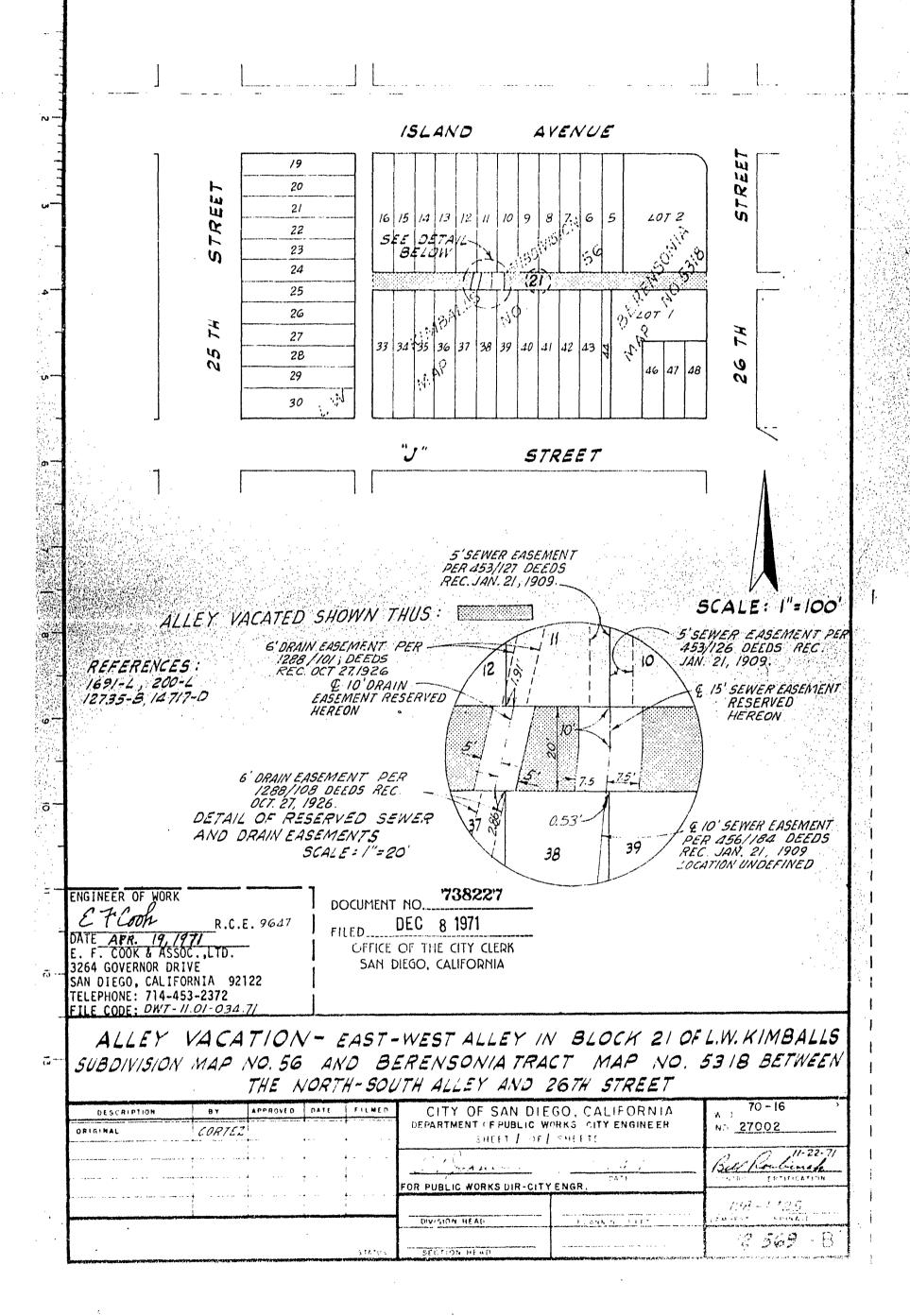
