APPROVING MAP OF GOLFVIEW ESTATES SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "GOLFVIEW ESTATES Being a resubdivision of Golfview Apartments, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6104, filed in the office of the County Recorder of said County, May 14, 1968, together with a portion of Golfcrest Drive and a portion of Navajo Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress for the construction and maintenance of sewer facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in the certificate signed by the Owners subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that

said Council has approved said subdivision map and that certain easement with the right of ingress and egress for the construction and maintenance of sewer facilities, together with the easements for general utilities and access purposes, and open space subject to the conditions expressed therein, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
