APPROVING MAP OF ONG SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by JAMES L. HALE, Licensed Land Surveyor, and entitled, "ONG SUBDIVISION Being a subdivision of the Easterly 264.00 feet of the Southeast Quarter of the Southeast Quarter of Section 6, Township 15 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved February 19, 1883 lying Southerly of the Southerly line of Bennett Subdivision, according to Map No. 5868 filed in the office of the County Recorder of San Diego County, April 20, 1967.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of a public street, to wit: a portion of Kearny Mesa Road, for public purposes, and said portion of street is hereby declared to be portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.

California.
