That the bid of \$185,337.70 by GRIFFITH COMPANY, a corporation, for the IMPROVEMENT OF PALM AVENUE BETWEEN BEYER WAY AND INTERSTATE 805, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document NO. 737670.

2. That the expenditure of \$220,300.00 is hereby authorized out of the Gas Tax fund (220) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF PALM AVENUE BETWEEN BEYER WAY AND INTERSTATE 805 in the City of San Diego, and related costs.
