BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Neptune Meter Co., 2. Singer Company, American Meter Controls Division, 3. Gamon/Calmut Industries, Inc., 4. Rockwell Manufacturing Co., 5. Badger Meter, Inc., 6. Hersey Products Inc., 7. Municipal and Utility Engineering Sales Company, 8. Western Water Works Supply Co., 9. Park Son Meter Parts Inc. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of COLD WATER METERS AND PARTS for a period of one year beginning January 1, 1972 and ending December 31, 1972 per prices on file in the Purchasing Department as follows:

1. Neptune Meter Co. for Schedule I, items 1 and 5, and for Neptune Meter Parts at 16½% trade discount from list prices, terms net 30 days, plus sales tax.

2. Singer Company, American Meter Controls Division for Schedule I, items 2, 3, 4 and 6, and for Singer American Meter Parts at 10% trade discount from list prices, terms 1%, 10th prox. plus sales tax with option to renew the contract for an additional one year period, January 1, 1973 through December 31, 1973 at the same prices, terms and conditions.

3. Gamon/Calmet Industries Inc. for Schedule II, items 2 and 3 and for Gamon/Calmet Meter Parts at 15% trade discount from list prices, terms net plus sales tax with option to renew the contract for an additional one year period, January 1, 1973 through December 31, 1973 at the same prices, terms and conditions.

4. Rockwell Manufacturing Co. for Schedule II, item 1 and for Rockwell Meter Parts at 15% trade discount from list prices, terms net plus sales tax.

5. Badger Meter, Inc. for Schedule II, items 5 and 6 and for Badger Meter Parts at 18% trade discount from list prices for Badger Domestic Meters and at 8% trade discount from list prices for Badger Commercial Meters; terms net 30 days plus sales tax.

6. Hersey Products Inc. for Schedule II, item 4, Schedule III, items 1, 2, 3, and 4, and Schedule IV, items 1, 2, 3, and 4, and Schedule V, items 1, 2, 3, 4 and 5, and for Hersey Meter Parts at 25% trade discount from list prices; terms net 30 days plus sales tax; with option to renew the contract for an additional one year period, January 1, 1973 through December 31, 1973 at the same terms, prices and conditions.

7. Municipal and Utility Engineering Sales Company for parts for various water meters at a trade discount of 5% from list prices, terms net, plus sales tax, F.O.B. Houston, Texas.
