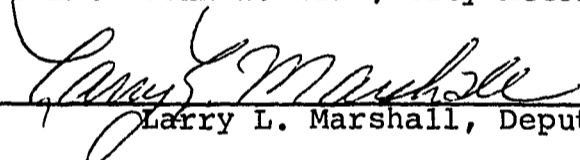
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE CHRISTIANA COMPANIES, INC., a California corporation, which acquired title as CHRISTIANA OIL CORPORATION, a Delaware corporation, executed in favor of The City of San Diego, bearing date December 15, 1971, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 73 of Rancho Mission of San Diego, according to the Partition Map thereof made in Superior Court Case No. 348 of San Diego County and filed in the Office of the County Recorder of San Diego County as Map No. 330 and in Lot 8 of Rosedale Tract according to Map thereof No. 825, filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SANTO ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
