ORDINANCE NO. 10766
(New Series)

AN ORDINANCE INCORPORATING THAT AREA LOCATED IN THE VICINITY OF MORENA BOULEVARD, GENERALLY BETWEEN MCGRAW STREET ON THE NORTH AND TECOLOTE ROAD ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CS AND CA-S ZONES, AS DEFINED BY SECTIONS 101.0432 AND 101.0428 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That area located in the vicinity of Morena Boulevard, generally between McGraw Street on the north and Tecolote Road on the south, in the City of San Diego, California, within the boundary of the districts designated "CS" and "CA-S" on Zone Map Drawing No. C-308.1, filed in the office of the City Clerk under Document No. 738109 be, and it is hereby incorporated into CS and CA-S Zones, as such zones are described and defined by Sections 101.0432 and 101.0428, respectively, of the San Diego Municipal Code.

Section 2. That the following Ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith:


