ORDINANCE NO. 10767  
(New Series)

AN ORDINANCE INCORPORATING THAT CANYON AREA LYING NORTHERLY OF LA JOLLA CORONA DRIVE AND LA CANADA, SOUTHERLY OF MUIRLANDS VISTA WAY, EASTERLY OF WAVERLY AVENUE AND FOLSOM DRIVE AND WESTERLY OF HAVENHURST DRIVE AND TERRYHILL DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO LC ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That canyon area lying northerly of La Jolla Corona Drive and La Canada, southerly of Muirlands Vista Way, easterly of Waverly Avenue and Folsom Drive, and westerly of Havenhurst Drive and Terryhill Drive, in the City of San Diego, California, within the boundary of the district designated "LC" on Zone Map Drawing No. C-346, filed in the office of the City Clerk as Document No. 738054 be, and it is hereby incorporated into LC Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
