ORDINANCE NO. 10776
(New Series)

AN ORDINANCE INCORPORATING PARCEL "A," O. D. ARNOLD'S BONNIEVIEW NO. 2; PORTIONS OF LOTS 61, 62, 65, 66, 70 OF EX-MISSION LANDS; LOTS 86 THROUGH 118, O. D. ARNOLD'S BONNIEVIEW NO. 3; AND A PORTION OF GROFF MANOR, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 78 (NEW SERIES), ADOPTED NOVEMBER 14, 1932, AND ORDINANCE NO. 3821 (NEW SERIES), ADOPTED AUGUST 10, 1948, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That parcel "A," O. D. Arnold's Bonnieview No. 2; portions of Lots 61, 62, 65, 66, 70 of Ex-Mission Lands; Lots 86 through 118, O. D. Arnold's Bonnieview No. 3; and a portion of Groff Manor, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. B-2567, filed in the office of the City Clerk under Document No. 738429 be, and they are hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 78 (New Series), adopted November 14, 1932 and Ordinance No. 3821 (New Series), adopted August 10, 1948, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.

This ordinance shall take effect and be in force on the thirtieth day from and after its passage and no buildings shall be constructed which do not conform to the provisions of the "R-1-5" Zone unless the application for a building permit was filed with the City of San Diego prior to the date of introduction of this ordinance.
