AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 10197 (NEW SERIES), ADOPTED DECEMBER 2, 1969, INCORPORATING A PORTION OF THE NORTHWEST 1/4 OF SECTION 32, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-1 ZONE, AS DEFINED BY SECTION 101.0404 (C-1A UPON RECORDATION OF MAP OR MAPS, AS DEFINED BY SECTION 101.0431) OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 10197 (New Series), adopted December 2, 1969; and

WHEREAS, Section 1 of Ordinance No. 10197 (New Series), provided that the C-1A Zone would attach if a final subdivision map or maps were recorded on or before January 1, 1972; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 10197 (New Series), adopted December 2, 1969, be, and it is hereby amended to read as follows:

Section 1. That in the event that a portion of the Northwest 1/4 of Section 32, Township 14 South, Range 2 West, S.B.B.M. in the City of San Diego, California, within the boundary of the district designated "A-1-1" on that certain Zone Map Drawing No. B-2189, filed in the office of the

City Clerk under Document No. 729981 be, and it is hereby incorporated into A-1-1 Zone as defined by Section 101.0404 of the San Diego Municipal Code; provided, however, that if a final subdivision map or maps is recorded on the said described area, on or before January 1, 1973, and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the said described land shall be incorporated into C-1A Zone as described by Section 101.0431 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
