ORDINANCE NO. 10788 (New Series)

AN ORDINANCE INCORPORATING LOTS 215 THROUGH 223, MESA HILLS, UNIT 4 AND LOT 304, RESUBDIVISION NO. 1 OF MESA HILLS, UNIT 4, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7882 (NEW SERIES), ADOPTED MAY 27, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 215 through 223, Mesa Hills, Unit 4 and Lot 304, Resubdivision No. 1 of Mesa Hills, Unit 4, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. B-2566.2, filed in the office of the City Clerk under Document No. 738976 be, and they are hereby incorporated into R-1-5 Zone, as such zone is described and defined in Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7882 (New Series), adopted May 27, 1958, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
