AN ORDINANCE AMENDING ORDINANCE NO. 10610 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1971-72 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 735821, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE POSITION AND SALARY SCHEDULE FOR FUND 100, DEPARTMENT 09.00.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Ordinance No. 10610 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1971-72 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion of the Position and Salary Schedule for Department 09.00, Fund 100, pertaining to the Civil Division, to reflect and authorize the addition of one Chief Deputy City Attorney.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
