AN ORDINANCE INCORPORATING LOTS 13 AND 14, POINT LOMA PARK, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8635 (NEW SERIES), ADOPTED ON MAY 10, 1962, AND ORDINANCE NO. 9891 (NEW SERIES), ADOPTED ON OCTOBER 10, 1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 13 and 14, Point Loma Park, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2584, filed in the office of the City Clerk under Document No. 738914 be, and they are hereby incorporated into CO Zone, as such zone is described and defined in Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8635 (New Series), adopted on May 10, 1962 and Ordinance No. 9891 (New Series), adopted on October 10, 1968, of the Ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
