AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0901 RELATING TO RESTRICTION ON REAPPLICATION FOR A PLANNED RESIDENTIAL DEVELOPMENT PERMIT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, of the San Diego Municipal Code be amended by adding Section 101.0901 to read as follows:

SEC. 101.0901 RESTRICTION ON REAPPLICATION FOR A PLANNED RESIDENTIAL DEVELOPMENT PERMIT

No application for a planned residential development permit on the same property or essentially the same property, for which a permit has been denied by the Planning Commission or City Council, shall be accepted within 12 months of such denial. This provision may be waived by the affirmative vote of a majority of the City Council.

This ordinance shall take effect and be in force Section 2. on the thirtieth day from and after its passage.


