AN ORDINANCE INCORPORATING A PORTION OF LOT 68, EX-MISSION LANDS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 78 (NEW SERIES), ADOPTED ON NOVEMBER 14, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That a portion of Lot 68, Ex-Mission Lands, Section 1. in The City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. B-2600, filed in the office of the City Clerk under Document No. 739251 be, and it is hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 78 (New Series), adopted November 14, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

This ordinance shall take effect and be in force Section 3. on the thirtieth day from and after its passage.
