ORDINANCE NO. 10826 MAY 111972

AN ORDINANCE INCORPORATING A PORTION OF LOT 8, AND ALL OF LOTS 9 THROUGH 21, BLOCK 210, UNIVERSITY HEIGHTS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE, AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 12820, APPROVED APRIL 28, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded on a portion of Lot 8, and all of Lots 9 through 21, Block 210, University Heights, in the City of San Diego, California, designated "C-1S" on Zone Map Drawing No. B-2611.1, the provisions of Section 101.0430 of the San Diego Municipal Code shall attach and become applicable to the said land and said land shall be incorporated into C-1S Zone, as described by Section 101.0430, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2611.1, filed in the office of the City Clerk as Document No. 739536.

Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 12820, approved April 28, 1930, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
