AN ORDINANCE INCORPORATING A PORTION OF LOT 35, PARTITION OF RANCHO MISSION OF SAN DIEGO AND A PORTION OF ZSCHOCKELTZ'S SUBDIVISION, LOCATED ON THE NORTH OF INTERSTATE 8, BETWEEN INTERSTATE 805 AND INTERSTATE 15, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 35, Partition of Rancho Mission of San Diego and a portion of Zschockeltz's Subdivision, located on the North of Interstate 8, between Interstate 805 and Interstate 15, in the City of San Diego, California, within the boundary of the district designated "R-1-40" on Zone Map Drawing No. B-2614, filed in the office of the City Clerk as Document No. 739665 be, and they are hereby incorporated into R-1-40 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
