

ORDINANCE NO. 10840

AN ORDINANCE INCORPORATING LOTS 13, 14, AND 17 THROUGH 22, BLOCK 43, FOREMAN AND HARDING'S SUBDIVISION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-S ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 32 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded on Lots 13, 14, and 17 through 22, Block 43, Foreman and Harding's Subdivision, in the City of San Diego, California, designated "CA-S" on Zone Map Drawing No. B-2613.1, the provisions of Section 101.0428 of the San Diego Municipal Code shall attach and become applicable to the said land and said land shall be incorporated into CA-S Zone, as described by Section 101.0428, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2613.1, filed in the office of the City Clerk as Document No. 739677.


Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 32 (New Series), adopted September 12, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
