AN ORDINANCE AMENDING ORDINANCE NO. 9708 (NEW SERIES), INCORPORATING COUNCIL POLICY 700-20 CONCERNING RESTRICTIONS ON USE OF FEDERAL FUNDS FOR URBAN RENEWAL PROJECTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 9708 (New Series), adopted October 24, 1967, be, and it is hereby amended by amending Section 2 and adding Section 3 to read as follows:

Section 2. The provisions of this ordinance shall not apply to the proposed urban renewal project area designated as the Linda Vista Redevelopment Project Area, the approximate boundaries of which area are set forth in a document on file with the City Clerk as Document No. 740069, and said Linda Vista Redevelopment Project Area is specifically exempt from the limitations imposed by Section 1 hereof.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


