

ORDINANCE NO. 10848
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 1312 AND 1313, AND LOTS 1 THROUGH 16, AND 50 THROUGH 93 AND LOT A, LA JOLLA FARMS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-10 AND R-1-20 ZONES, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13455, APPROVED FEBRUARY 15, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Pueblo Lots 1312 and 1313, and Lots 1 through 16, and 50 through 93 and Lot A, La Jolla Farms, in the City of San Diego, California, within the boundaries of the districts designated "R-1-10" and "R-1-20" on Zone Map Drawing No. B-2618.1, filed in the office of the City Clerk under Document No. 740036 be, and they are hereby incorporated into R-1-10 and R-1-20 Zones, as such zones are described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13455, approved February 15, 1932, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
