AN ORDINANCE INCORPORATING CERTAIN PROPERTY IN THE MIRAMAR, ELLIOTT AND MISSION GORGE AREAS, LOCATED EAST OF INTERSTATE 15 AND GENERALLY SOUTH OF POMERADO ROAD, WEST OF THE CITY LIMITS AND NORTH OF MISSION GORGE ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 AND R-1-40 ZONES, AS DEFINED BY SECTIONS 101.0404 AND 101.0407, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 10038 (NEW SERIES), ADOPTED MAY 8, 1969, ORDINANCE NO. 8819 (NEW SERIES), ADOPTED MAY 2, 1963, AND ORDINANCE NO. 8349 (NEW SERIES), ADOPTED SEPTEMBER 1, 1960, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That certain property in the Miramar, Elliott, and Mission Gorge areas, located east of Interstate 15 and generally south of Pomerado Road, west of the City limits and north of Mission Gorge Road, in the City of San Diego, California, within the boundary of the districts designated "A-1-10" and "R-1-40" on Zone Map Drawing No. C-367.2, filed in the office of the City Clerk as Document No. 740320 be, and it is hereby incorporated into A-1-10 and R-1-40 Zones, as such zones are described and defined by Sections 101.0404 and 101.0407, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 10038 (New Series), adopted May 8, 1969, Ordinance No. 8819 (New Series), adopted May 2, 1963, and Ordinance No. 8349 (New Series), adopted September 1, 1960, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.
